- REQUIREMENTS – all requirements must be met in order to participate:
 - Must be a female, at least 16 years of age, but not over 20, by June 1, 2010
 - Completed **2 years** competitive experience at the Westmoreland Fair
 - Must be a U.S. Citizen and a resident of **Westmoreland County, Pennsylvania**
 - Must be a **current, 2 year member** of the organization representing or affiliated with
 - One entrant per 4-H, FFA Club or organized agricultural organization
 - Have not been a former local Fair Queen winner, nor a former State Fair Queen contestant
 - Not hold any other title for any other commodity group or pageant
 - Must have Parental Consent
 - Must be single, have never been married, have not been pregnant, nor get pregnant during her reign, nor given birth to a child.
 - Must be of good moral character
 - Must be able to meet all time commitments, Queen obligations and dress code as set forth by the PA State Fair Queen Program.
- EACH ELIGIBLE CONTESTANT WILL:

- Submit a written essay with application on “What My Fair Means to My Community” (300 words or less)
- Give a short speech the night of the contest on “Why You Should Come to My Fair”
- Attire for the Queen pageant – evening gown
- Must be able to attend the interview and pageant as scheduled
- Attend as many fair week events and dress appropriately if chosen as Fair Queen
- The young woman who is selected as Westmoreland Fair Queen will assist with award presentations during fair week and will represent the fair at certain functions during the year.
- The Fair Queen will be the certified contestant for the State Fair Queen pageant and be eligible to compete for a \$1,000 scholarship.
- The contestants will be judged on Fair involvement, essay, character, personality, poise, appearance, speaking ability, and knowledge of the fair industry.
- The Westmoreland Fair Association pays the queen’s expenses for her to attend the state fair queen competition in January at Hershey.

The Pennsylvania Department of Agriculture is excited to become involved in a “Fun Safety Initiative” to increase fair safety awareness. This year’s contest will promote the importance of fun safety and utilize the theme: “**Fun and Safety on The Fairgrounds.**” The poster exhibits will further promote the Fun-Safety concept as visitors view the individual entries. The poster should contain items pertaining to **amusement rides** and any or all of the items listed below:

1. Tram-fairground to and from parking lot transportation
2. Livestock-bite-kick-runaway-hand-feeding hazards
3. Horse drawn wagons and equipment dangers
4. Tractors and tractor drawn equipment dangers

- 5. Caged poultry and animal hazards
- 6. Trip hazards
- Only one poster (size 14 ½” X 22”) may be submitted per student, per age group – ages 8-11, 12-14, and 15-18. Each entry must fit into his/her age category as of June 1, 2010.
- Only one poster per age group per fair may be forwarded for the state competition. The Fair Entry Secretary will be responsible for sending the poster and certification to The Department of Agriculture.
- Cash prizes of \$100, \$75, and \$50 will be awarded to the top three entries in each age group during the Pennsylvania State Farm Show, January 2011.
